	<ul> <li>5 sites/hospitals have started entering data</li> <li>409 cases entered (as of 11 April 2012)</li> </ul>
Dilhai	<ul><li>5 sites/hospitals have started entering data</li><li>311 cases entered (as of 11 April 2012)</li></ul>

### Using Export Data Online

#### **Updates**

- Taipei, Korea, Japan using this method
- Requires recoding and matching of data variables
- Data recoding for Taipei, Korea and Japan (Osaka & Tokyo) has been completed
- Require data dictionary or taxonomy (in English) from each country who is using the export method to better facilitate data matching of variables

### 2. Data Reconciliation Progress



- Reconciliation of data coding for Taipei, Osaka and Tokyo has been completed
- Reconciliation of data coding for Korea is still in progress - pending clarifications

Singapore	2010 to 2012	1 500
Taiwan (abt 400 cases x 3mths)	2010 to 2011	3 200
Osaka (abt 2200 cases x 3mths)	2010 to 2011*	16 000
Tokyo	2010 to 2011	115 000
Korea	2010 to 2011	50 000
Dubai	May 2011 to Sep 2012	500
Malaysia	Dec 2010 to Sep 2012	600
Thailand	Oct 2011 to Sep 2012	100



#### Responsibilities for Each Site

- Regardless of data entry method, each site is responsible for data cleaning and verification (i.e. clean and complete data) before it is being sent to PAROS Coordinator for analysis.
- Each site has to ensure that they meet the data contribution requirement during the specified period.



Additional Responsibilities for Each Country / Region Using Data Migration (Japan, Korea, Taiwan)

- English version of data dictionary to be provided.
- 2 year data (2010-2012) to be provided by May 2012. Preferred period for data (Jan 2010 - Dec 2011).
