- There are 9 Hospital
 - 1 Class I Referral Hospital
 - 1 Army Hospital
 - 7 Private Hospital
- No established EMS system
- Lack of prehospital information
- No Recorded data about OHCA → no study about OHCA

Prehospital Care in Indonesia


- 1990 : 118 Emergency Ambulance Service project begin (7 Cities)
- 1997 : Emergency Medicine Program Education is establish but not recognized as nationwide need
- 2000 now :
 - 118 Ambulance Service substandard \rightarrow no establish EMS

• 2015 :

- Government Planned to Develop National Integrated Emergency and Disaster System (SPGDT)
- Emergency Medicine Specialist Association (PERDAMSI) is recognized → assigned to plan SPGDT

Challenges

- The need to collecting OHCA data based on recommended Utstein style reporting
- To provide benchmarking, measurement and feedback regarding upcoming SPGDT project (EMS Indonesia)
- Linked 9 hospital to increase awareness and the importance about OHCA



Pilot Strategy in Malang

- Raising the awareness of SCA, teaching how to do CPR and to use AED among lay person
 - Project conducting by Emergency Nursing University Brawijaya

- 36,6 % Ambulance
- 22,6 % Own/Private Transport
- 12 % Rent Transport
- 21, 8 % Public Transport
- 6, 3% Others
- 0,7 % Police Transport

Progress Collecting Data OHCA

- OHCA data are collected from 2 hospital
 Saiful Anwar General Hospital Class I Referall Hospital
 Panti Waluya Catholic Hospital Private Hospital
- Agreement to collecting and recording OHCA data based on PAROS translated form for 1 year study (evaluated every 1 year)

Ethical Clearance

- Health Research Ethics Committee Medical Faculty of University Brawijaya
- Collecting data started at August 2015
- \rightarrow 30 data are collected until know
