### Proposal submission process --

Secretariat calls for new secondary study proposals submission

Secretariat collates and submit the proposals for review and approval by the PAROS chair and co-chairs

Study approval letter will be send out once study approved by the PAROS chairs and co-chairs

(letter send out date = proposal approval date)

# **Publication Committee Announcement**

### **Authorship Allocation --**

Eligible Author List will be included in the New Study Proposal Submission Form.

Note: Eligible author = Data Contributing Site PI/ PAROS EXCO

 PI may propose the co-authors from the Author List in the Study Proposal. Other authors contributing to the study may also be suggested.

#### OR

2. If not indicated on the submitted form, secretariat will call for applications to be a study author. A list of the approved studies will be send to the eligible authors. Interested members may apply for the study co-authors through the secretariat.

Final authors list is subjected to approval by the PAROS chairs. A confirmation email will be send to all the study co-authors once the list is finalized.

### Author Responsibilities:

- Contribute in writing or ideas or analysis or data
- Response to queries or review of the manuscript
- First and corresponding authors have the rights to exclude any members from the authorship if they are not contributing

### **Authorship Guidelines:**

- To have at least 1 representative per data contributing site
- To have at least 1 PAROS chairs
- Not more than 10 authors preferred
- To acknowledge PAROS in the paper

# **Publication Committee Announcement**

### Study timeline --

To complete and publish the study:

- Within 2 years from the proposal approval date if it's a secondary analysis of the existing data
- Within 4 years from the proposal approval date if it's a new study requiring additional data

If there is no publication after the stated timeline, your study will be withdrawn and the topic will be release to other interested members

Appeal for extension will be granted on a case by case basis

## Pilot Program: Resuscitation Alliance (RA) 10-steps Implementation Feasibility Assessment Workshop for Developing Countries

### What you need to know about the GRA 10-Steps

During the 2015 Consensus on Science and Treatment Recommendations, the International Liaison Committee (ILCOR) and the Resuscitation Academy (RA) promoted the following implementations for better OHCA outcomes:

- 1. Establish a cardiac arrest registry;
- 2. Begin Telephone-CPR with ongoing training and quality improvement (QI);
- 3. Begin high-performance EMS CPR with ongoing training and QI;
- 4. Rapid dispatch;
- 5. Measure professional resuscitation using the defibrillator recording;
- 6. Use smart technologies, such as smartphone applications, to notify volunteer bystanders who can respond to nearby arrest to provide early CPR and defibrillation;
- 7. AED program for first responders, including police officers, security personnel, etc.;
- 8. Make CPR and AED training mandatory in schools and the community;
- 9. Work toward accountability submit annual reports to the community;
- 10. Work towards a culture of excellence.

### **Background on the Feasibility Assessment Workshop :**

In the consensus meeting in Singapore on 1-2 Aug 2017, it was agreed that in developing EMS systems these RA 10-Steps may not be easily achievable, certain pre-requisites or bridging elements may be needed before the implementation of the RA 10-Steps.

This workshop provides a toolkit to assess the feasibility of application of the GRA 10 steps in the state/country, reviewing what is currently in existence & gaps in the area of community, dispatch, ambulance and healthcare facilities respectively.

### Pan-Asia Resuscitation Outcome Study (PAROS) Clinical Research Network EXCO Meeting

PAROS Clinical Research Network in collaboration with the Asian Association for Emergency Medical Services (AAEMS) held the group's annual EXCO meeting on 17 June 2018. Following the EXCO meeting is a 2-day conference, EMS Asia 2018, organized by the AAEMS. Some of the PAROS members are invited speakers at the conference.

At the PAROS EXCO meeting, A/Prof Marcus Ong discussed the PAROS 2 data analysis plan and data-related issues. The status of the secondary studies publications and the progress of the implementation of the Resuscitation Academy 10-steps program in the various PAROS countries were also presented.
